APPLICATION PROCESS: Applications for membership will be accepted at anytime. A Permanent or Life Member of the Club must sponsor each applicant. The applicants name shall be read to the membership at the next monthly membership meeting after receipt of the application. The applicant is asked to be present for the following monthly membership meeting where their sponsor to the membership will introduce them and a vote on the Provisional Membership application will be conducted.

PROVISIONAL MEMBERSHIP OBLIGATIONS: All applicants are obligated to complete a Provisional Membership period during which you are required to perform 24 hours of approved service to the club and attend a minimum of 2 membership meetings. Upon completion of the service and meeting attendance requirements, a vote for Permanent Membership in accordance with the By-Laws, will be taken at the next regularly scheduled membership meeting. This decision will be based on the applicant's completion of the Provisional Membership obligations, payment of all dues and fees and demonstrated support, and general interest in the well being of the club.

Provisional Members are encouraged to take an active part in club activities and get to know the club members while completing their service and meeting obligations.

PERMANENT MEMBERSHIP OBLIGATIONS: The By-Laws of the club mandate a work requirement for all Permanent Members of 24 hours per calendar year for the first 5 years of Permanent Membership at registered shoots, work days, or other activities as prescribed by the BY-LAWS or club policy. Failure to meet this requirement will result in an additional assessment of \$100.00 per year in addition to the regular club dues. Permanent Members must complete the Personal Access Request form and agree to accept the responsibilities outlined on the form before receiving keys to the club facilities. All Permanent Members are required to attend 2 meetings per year. Failure to do so may result in loss of membership.

AT WILL MEMBERSHIP: The Tuscarora Gun Club, a private club governed by By-Laws provides an "At Will" relationship between its members and the organization. The rights of a member of a Private Club which is governed by the By-Laws constitutes the total agreement between the club and the member.
